 *MGMT module is pre-installed by MOXA before shipment.
- 2. FPGA code update. This change does not affect the form, fit, or functionalities and certifications of the MDS-G4000 Series.
- 3. We will remove the RJ45-to-RS-232 9-pin female console cable from the package to achieve environmental protection without waste. Find Accessories (sold separately) information in the datasheet for your selection.
