We would like to inform you that Moxa is going to discontinue the V2201-E1-T-W7E. This discontinuation is because of the end of support for Windows 7 Embedded, which will no longer be available as an operating system option for the V2201 Series. The V2201 Series itself will continue to be available. Supported operating systems will still include Windows 10 IoT Enterprise 2016/2019/2021 and Linux Debian 9.
